**NOTICE FOR ORAL HEARING**

**Subject: Oral Hearing in the matter of countervailing duty investigation concerning imports of “Digital Offset Printing Plates” originating in or exported from China PR and Taiwan.**

Sir/Madam,

The Authority had initiated a countervailing duty investigation concerning imports of “**Digital Offset Printing Plates**” originating in or exported from **China PR and Taiwan** on 29.09.2023. As per Rule 7 (6) of the CVD Rules “*The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing*”.

2. In pursuance of the aforesaid provision, the Designated Authority has scheduled an oral hearing on **9<sup>th</sup> April 2024 at 2:30 PM (IST)**. The hearing will be held in hybrid mode i.e., both through Digital Video Conferencing (DVC) and physically in the conference room of DGTR.
