Subject: Countervailing duty/Anti-Subsidy Investigation concerning import of Soda Ash originating in or exported from Turkey.

1. With reference to the above-mentioned investigation, it has been informed by M/s ELP on behalf of their client, M/s Hindustan Unilever Limited (HUL) vide email dated 23.11.2020 that HUL has not been included in the Revised List of Interested Parties issued on 17 November 2020. They have requested to include HUL as an interested party in the captioned investigation and also share the submissions of the other interested parties.
2. In this regard, the Authority notes that vide notice dated 11.11.2020, a list of interested parties was published on the website of DGTR with a request to inform the Authority in case any name was inadvertently missed. On receipt of comments from some interested parties, this list was subsequently revised and published on the website on 17.11.2020. It is further noted that, no representation was made by M/s ELP regarding non-inclusion of their name in the original/revised list of interested parties.
3. However, taking into account their email dated 23.11.2020, the Authority allowed M/s ELP to participate in the Oral Hearing scheduled on 23.11.2020.
4. In view of above, all interested parties are now requested to include M/s ELP in their mailing list for the subject investigation so that M/s ELP also receives all the responses/submissions made. A revised list of interested parties is also annexed. Further, since M/s ELP has not received any responses so far, all interested parties are requested to forward their responses to M/s ELP immediately so as to enable them to make written submissions consequent to the Oral Hearing held on 23.11.2020 by stipulated date i.e. 08.12.2020.
