Subject: Clarification regarding PUC under Initiation Notification concerning imports of Elastomeric Filament Yarn – Identification of PCN reg.

With reference to Initiation Notification No. 14/29/2015/ DGAD dated 27th January, 2016 concerning imports of "Elastomeric Filament Yarn of all deniers up to and including 150 Deniers excluding coloured yarns, originating in or exported from China PR, South Korea, Taiwan and Vietnam", requests were received from the interested parties, to allow them to present their information on PCN basis in order to have fair comparison between normal value and export price. The matter has been examined and it has been decided by the Designated Authority to issue following PCN and that the cooperating exporters and DI may indicate the PCN of each of the transactions in the various appendices filed by them. The costing information may also be provided for each of the PCNs separately.
