Subject: Sunset Review of anti-dumping duty imposed on imports of "New/unused pneumatic radial tyres with or without tubes and/or flap of rubber (including tubeless tyres) having nominal rim dia code above 16" used in buses and lorries/trucks", originating in or exported from China PR.
