NOTICE FOR ORAL HEARING

Subject: Oral hearing in Anti-Dumping investigation concerning alleged circumvention of anti-dumping duty imposed on imports of “Ceramic Tableware and Kitchenware, excluding knives and toilet items” originating in or exported from China PR, by imports of “Ceramic Tableware and Kitchenware, excluding Knives and Toilet Items” from Malaysia.

A Anti-Circumvention investigation concerning alleged circumvention of anti-dumping duty imposed on imports of “Ceramic Tableware and Kitchenware, excluding knives and toilet items” originating in or exported from China PR, by imports of “Ceramic Tableware and Kitchenware, excluding Knives and Toilet Items” from Malaysia was initiated on 25th September, 2020 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules “*The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing*”.

2. In pursuance of the aforesaid provision, and the prevailing Covid-19 pandemic, Designated Authority has scheduled an oral hearing in the matter through Digital Video Conference (DVC) to be held on 23rd February 2021 at 15.00 hrs. (IST).
3. You will be required to submit written submissions and the rejoinders (confidential and non-confidential versions) of the views expressed at the hearing within the date and time schedule to be indicated on the date of hearing.
