Subject: Oral Hearing of anti-circumvention investigation concerning alleged circumvention of anti-dumping duty imposed on imports of High Tenacity Polyester Yarn originating in or exported from China PR.

1. anti-dumping investigation concerning imports of High Tenacity Polyester Yarn originating in or exported from China PR, was initiated on 27.07.2022 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules *“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*.
2. In pursuance of the aforesaid provision, and the prevailing Covid-19 pandemic, the Designated Authority has scheduled an oral hearing in the matter through Digital Video Conference (DVC) via NIC Webex to be held on **20.10.2022 at 2:30 PM**.
