Subject: Oral Hearing of Sunset Review of Anti-Dumping Duty investigation concerning imports of “Melamine” from China PR.

A Sunset review of Anti-Dumping investigation on imports of “Melamine” was initiated on 22.09.2020 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules *“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*.

2. In pursuance of the aforesaid provision, and the prevailing Covid-19 pandemic, Designated Authority has scheduled an oral hearing in the matter through Digital Video Conference (DVC) via NIC Webex to be held on 16.11.2020 at 16:30 hrs. (IST).
