NOTICE FOR 2nd ORAL HEARING

Subject: 2nd Oral Hearing of Sunset Review of Anti-Dumping investigation concerning imports of “Methyl Acetoacetate” originating in or exported from China PR.

1. A Sunset review of Anti-Dumping investigation on imports of “Methyl Acetoacetate” was initiated on 30.09.2020 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules *“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*.
2. In pursuance of the aforesaid provision, 1st Oral Hearing was held on 21.12.2020 wherein the interested parties filed written and rejoinder submissions also.
3. The 2nd Oral Hearing has been necessitated due to the reason that **Shri B.B. Swain, IAS**, the then Designated Authority at the time of first oral Hearing held on 21.12.2020, has been succeeded by **Shri Anant Swarup, Designated Authority**.
4. The new Designated Authority has scheduled **2nd Oral Hearing** in the matter through Digital Video Conference (DVC) via NIC WebEx to be held on **18.02.2021 at 3:00 PM to 4:30 PM**.
5. You will be required to submit written submissions and the rejoinders (confidential and non-confidential versions) of the views expressed at the hearing within the date and time schedule to be indicated on the date of hearing.
