**NOTICE FOR ORAL HEARING**

**Subject: Oral Hearing in the matter of anti-dumping investigation concerning imports of ‘Poly Vinyl Chloride Paste Resin’ originating in or exported from China PR, Korea RP, Malaysia, Norway, Taiwan & Thailand.**

1. The Authority had initiated an anti-dumping investigation concerning imports of **‘Poly Vinyl Chloride Paste Resin’** originating in or exported from **China PR, Korea RP, Malaysia, Norway, Taiwan & Thailand** on 30.09.2023. As per Rule 6 (6) of the AD Rules *“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*.
2. The oral hearing in the subject investigation was conducted on 13<sup>th</sup> August 2024 at 2:30 PM (IST). However, due to the appointment of the new Designated Authority it is mandated that an Oral hearing be held by the new Designated Authority as per the judgement of the Hon’ble Supreme Court in the matter of ‘Automotive Tyre Manufacturers’ Association (ATMA) vs. Designated Authority, delivered in Civil Appeal No. 949 of 2006 on 07-01-2011.
3. In pursuance of the aforesaid provision, the Designated Authority has scheduled an oral hearing on **13<sup>th</sup> September, at 3:00 PM (IST)**. The hearing will be held in hybrid mode i.e., both through Digital Video Conferencing (DVC) and physically in the conference room of DGTR.
