TERMINATION NOTIFICATION

Subject: Termination of New Shipper Review (under Rule 22) of Anti-Dumping duty imposed on imports of Nylon Tyre Cord Fabric (NTCF) originating in/or exported from China PR.

No.15/24/2006-DGAD. Having regard to the Customs Tariff Act 1975 as amended in 1995 and the Customs Tariff (Identification, Assessment and Collection of Anti-Dumping Duty on Dumped Articles and for Determination of Injury) Rules, 1995(hereinafter referred to as AD Rules), thereof:

2. Whereas M/s. Qingdao Lian Chuang Stock Company Ltd., China PR (hereinafter referred to as Applicant) filed an application in accordance with the Customs Tariff Act, 1975 as amended and Customs Tariff (Identification, Assessment and Collection of Anti-Dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 before the Designated Authority (hereinafter referred to as the Authority) requesting for a review under AD Rule 22 of the Anti-Dumping duty recommended by the Designated Authority on exports of Nylon Tyre Cord Fabric (NTCF) from China PR in the case of Anti-Dumping investigation where Government had notified the Anti-Dumping duty vide Notification No. 36/2005-Customs dated 27.4.2005 falling under Chapter 69 of Customs Tariff Act.

3. Whereas the Authority initiated the investigation under A D Rule 22 for determination of individual dumping margin vide Notification No.15/24/2006-DGAD dated 30.10.2007.

4. Whereas the Authority recommended provisional assessment on all exports of Nylon Tyre Cord Fabric made by M/s Qingdao Lian Chuang Stock Company Ltd., China PR till this review is completed, in accordance with the Rule 22 of the AD Rules and having regard to Notification No. 36/2005-Customs dated 27.4.2005.

5. Whereas the applicant was to submit the requisite information required for review within 40 days of issue of the initiation notification dated 30.10.2007. The applicant failed to submit the information within permitted time and vide letter dated 26.12.2007 informed that it will not participate in the investigation.

6. In view of the non-cooperation of the applicant as informed vide letter dated 26.12.2007, the Authority terminate the investigation initiated on 30.10.2007 and recommend assessment of the exports of Nylon Tyre Cord Fabric made by M/s Qingdao Lian Chuang Stock Company Ltd., China PR as per Notification No. 36/2005-Customs dated 27.4.2005
