NOTICE FOR ORAL HEARING

Subject: Oral Hearing in the matter of countervailing duty investigation concerning imports of ‘effect pearlescent pigments or mica pearlescent pigments, excluding effect pigments for automotive applications’ originating in or exported from China PR.

Sir/Madam,

1. The Authority had initiated a countervailing duty investigation concerning imports of ‘**effect pearlescent pigments or mica pearlescent pigments, excluding effect pigments for automotive applications**’ originating in or exported from **China PR** on 29.03.2024. As per Rule 7 (6) of the CVD Rules “*The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing*”.
2. In pursuance of the aforesaid provision, the Designated Authority has scheduled an oral hearing on **14th November 2024 at 2:30 PM (IST)**. The hearing will be held in hybrid mode i.e., both through Digital Video Conferencing (DVC) and physically in the conference room of DGTR.
