NOTICE FOR ORAL HEARING

Subject: Oral Hearing in the matter of Second Sunset Review anti-dumping investigation concerning Anti-dumping duties on imports of “Sodium Citrate” originating in or exported from China PR - reg.

1. The Authority had initiated second sunset review anti-dumping investigation concerning imports of “**Sodium Citrate**” originating in or exported from **China PR** on 30th September, 2024 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of the AD Rules “*The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing*”.
2. In pursuance of the aforesaid provision, the Designated Authority has scheduled an oral hearing on **17th December, 2024 at 3:00 PM (IST)**. The hearing will be held in hybrid mode i.e., both through Digital Video Conferencing (DVC) and physically in the conference room of DGTR.
