Product Under Consideration: “Non-Alloy and Alloy Steel Flat Products”.**

Section 1: General Information:

a. Complete information:

i. Name of the enterprise: Legal form/status and corporate structure of your enterprise. In case there have been any change in the structure of your company, please elaborate every change in the last three years, including the POI.

ii. Address and contact number: Complete correspondence address of your corporate/head office, along with telephone number, fax number, mobile number, and e-mail address.

iii. List the factories, if any, involved in the production of your product using the product under investigation, with complete correspondence address, telephone number, fax number, mobile number and e-mail address.

iv. List of products manufactured by you by using the product under investigation, along with description of product, grade, size, etc.

v. Contact person: Name, complete correspondence address, telephone number, fax number, mobile number and e-mail address of the principal contact person (or representative/legal representative in India or elsewhere for the purpose of this investigation).

b. Distribution and marketing channel: In home market and for exports outside India.
