NOTICE FOR ORAL HEARING

Subject: Oral Hearing in the matter of Anti-Subsidy investigation concerning imports of Textured Tempered Coated and Uncoated Glass originating in or exported from Malaysia.

Sir/Madam,

1. The Authority had initiated an anti-subsidy investigation concerning imports of “**Textured Tempered Coated and Uncoated Glass**” originating in or exported from **Malaysia** on 24th June, 2025 under the Customs Tariff (Identification, Assessment and Collection of Countervailing duty on Subsidized Articles and for Determination of Injury) Rules, 1995. As per Rule 7 (6) of the CVD Rules “*The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing*”
2. In pursuance of the aforesaid provision, the Designated Authority has scheduled an oral hearing on **23rd September 2025 at 3:00 PM (IST)**. The hearing will be held in hybrid mode i.e., both through Digital Video Conferencing (DVC) and physically in the conference room of DGTR.
