- a) On September 13, 2025 the U.S. Department of Commerce (Commerce) completed the final results of the 2023 countervailing duty administrative review on Granular Polytetrafluoroethylene Resin from India; C-533-900 covering the period 1/1/2023 – 12/31/2023. The Final rates of duties are as follows:
