**NOTICE FOR ORAL HEARING**

**Subject: Oral Hearing in the matter of sunset review of anti-dumping investigation concerning imports of “Seamless Tubes, Pipes & Hollow Profiles of Iron, Alloy or Non-Alloy Steel” originating in or exported from China PR.**

Sir/Madam,

The Authority had initiated a sunset review of anti-dumping duty on imports of “*Seamless Tubes, Pipes & Hollow Profiles of Iron, Alloy or Non-Alloy Steel*” originating in or exported from *China PR* on 20<sup>th</sup> March, 2026 under the Customs Tariff (Identification, Assessment and Collection of Anti-Dumping Duty on Dumped Articles and for Determination of Injury) Rules, 1995. As per Rule 6 (6) of the ADD Rules;

*“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*

1. In pursuance of the aforesaid provision, the Designated Authority has scheduled an oral hearing on **09<sup>th</sup> June, 2026 at 3:30 PM (IST)**. The hearing will be held through Digital Video Conferencing (DVC) only.
